SUMMARY

Dr Khoja worked as the **Vice-Dean** for Postgraduate and Research and the **Executive Director** of Health and Biomedical Research Center at IMSIU. At the national level, Dr. Khoja is the **Head of the Public health committee** at the Saudi Commission for health specialties. Besides, he is working as a **senior advisor to the Vision 2030 realization office** -Saudi Ministry of health- at Program for Health Assurance and Purchasing and is leading the National Health Benefits Package design project. Also, he is the project **lead for the population health management strategy and implementation.**

Moreover, he contributed to the management of the **third strategic objective** during the National Transformation Program workshops (**NTP 2020**) - the Ministry of Health file -: Value-based healthcare. Also, Dr. Abdullah participated **landmark national health surveys and studies** such as the health system assessment and responsiveness with the Saudi Health Council, the world health survey 2010 and led the technical and scientific committee of the Saudi world health survey during 2019 that address the main SDGs targets and most of the WHO's 100 indicators.
