### A. Course Description

Introductory to general kinds of animals' species (marine and terrestrial), their distribution within the Saudi Kingdom. The course will address the climate, geomorphology and their effect on animal life. It will expose students to the multi-disciplinary nature of wild animals, endemic and endangered species. Consideration of biological taxonomic systems and consideration of both vegetative features and reproductive features associated with local flora and fauna.
